

## **APT 2023 Seattle Conference Recap**



Seattle was a welcoming host city for APT's second inperson conference since the pandemic. The week started with three workshops focused on the conservation of engineered wood, documentation technology, and strategies for helping sites cope with natural disasters. Our opening keynote speaker, David Williams, deepened our understanding of how the land in Seattle was shaped (quite literally) in profound and astonishing ways during the city's early development.

Three tracks of paper sessions sparked discussion and the exchange of ideas. The College of Fellows keynote speaker, Yasmeen Lari, challenged us to consider unorthodox methods for addressing climatic and economic adversity through design that embraces traditional typologies. The conference closed with a symposium discussing conservation approaches to composite materials and assemblies encountered in modern heritage construction.



As always, we are grateful to the local conference committee; co-chairs Brian Rich and Maya Foty assembled a gracious and hardworking team. We heartily thank all our sponsors and exhibitors. We hope attendees visited with exhibitors and identified resources to assist with their current projects. We look forward to seeing everyone next year in Montréal!



## A Side Trip to Chihuly Garden and Glass (Museum)







In the shadow of Seattle's Space Needle, Dale Chihuly's glass museum is breathtaking and engaging. The color, size, composition, application, reflectivity, and variety of glass sculptures simply stuns. Some pieces are inside, sitting on glass that mirrors their displays, hanging in full blown wonder from the ceilings, employed as vibrant laylights, and mounted simply on pedestals. Exterior glass plants and shrubs are interspersed amid the natural vegetation, successfully vying for attention. And, using a kiln in an Airstream trailer, glass blowers demonstrate their creation of these flowing works of art.

The visit can be short or long, and repeated as necessary. It added a colorful dimension to our Seattle sojourn.

## **Member News**

**John Canning & Co.** earned the 2023 Bulfinch Historic Preservation Award for work at St. Mary-St. Catherine of Siena Parish in Boston, MA. This project involved a comprehensive finish restoration by Canning Liturgical Arts that included decorative painting, gold leafing, glazing, polychrome finishes, wood finishes, art conservation, metal restoration of fixtures, as well as plaster repair and replacement.

Both master craftsman **John Canning**, principal and founder of John Canning & Co. and **Past President Taryn Williams** were interviewed and featured on Peter Miller's *Building Tradition* podcast series. They, along with APT members **Aaron Ruby, Brian Goeken**, and **Matthew Chalifoux**, have been listed in the Who's Who in Traditional Building that includes 25 leaders who have made a difference in the world of traditional design and historic preservation. <u>That article is available here.</u>

The Boston office of **Beyer Blinder Belle (BBB)** has moved to 280 Summer Street in historic Fort Point, adjacent to the Seaport innovation district. This larger, self-designed space better positions BBB's growing Boston team—led by BBB Managing Partner Elizabeth Leber and BBB Principal and Director of the Boston Office Monica Siebenmorgen—to serve its world-class clients across New England.

The Preservation League of New York presented the 2023 Pillar of New York Award to **John G**. **Waite Associates, Architects** as one of their "Pillars of New York." In announcing the award, the Preservation League stated, "If you want to know what a professional commitment to preservation looks like, look no further than the firm JGWA."

In addition, **John G. Waite Associates, Architects** received a Lucy G. Moses Preservation Award from the New York Landmark Conservancy, for their exceptional work on the Castle Clinton National Monument, constructed in 1812. The Lucy G. Moses Awards are the Conservancy's highest honors for outstanding preservation efforts.


## **Membership Stories: Why I Belong to APT**

The invitation to join APTI came in 2011 from a colleague-member who shared the same professional interests in earthen construction and heritage preservation. At that time, there was a movement toward the creation of an APT Latin America and Caribbean Chapter (LAC) that could congregate and represent the work and research of the many professionals in Latin America and the Caribbean who attend APT conferences regularly. The new Chapter would focus on the peculiarities and interests of heritage preservation needs, considering the local realities of each country. However, it was only in 2020, during the pandemic, that the idea gained momentum, and the group of professionals started to define its objectives, structure and working committees.

Since then, I have been collaborating with the LAC Technical Committee on Sustainable Preservation and the LAC Training and Education Committee. As in all multicultural groups, eventually, the different languages spoken by the members - English, Portuguese and Spanish - can be a barrier, which is quickly surpassed by supportive and committed members and the will to make things happen. Being part of this multicultural community allows me to enlarge my professional repertoire and bring innovative solutions to my work.

Among my favorite preservation-related articles are: "The Importance of Vernacular Tradition" by Anita Rodriguez and Katherine Pettus (*APT Bulletin*, vol. 22, no. 3, 1990, pp. 2-4); and "Adaptive Reuse Strategies for Heritage Buildings: A Holistic Approach" by Damla Mısırlısoy, Kağan Günçe (*Sustainable Cities and Society*, vol. 26, 2016, pp. 91-98). Additionally, the content available in *Practice Points* is an interesting collection of the interface between research and practice.
